Receive and file report from Legal Counsel and General Manager on this agenda item. Provide direction to Legal Counsel and General Manager accordingly.

FISCAL IMPACT

Below is an estimate of the costs to videotape and post Board meetings which are open to the public on the District's website.

Videographer

- \$500 per meeting for videotaping (24 regular meetings/year = \$12,000, plus 12 committee/special meetings/year \$6,000). 36 total meetings.
- \$18,000 Annual Cost

Video hosting service

• \$1,620 one-time fee for website page build and hosting of 25 meetings/year (additional meetings would be extra)

Website design

Estimate \$500-\$1,000 one-time fee for I-frame page build

VRSD staff (posting of meeting videos)

- Estimate four hours per meeting (36 meetings 144 hours @ \$102/hour for Management Analyst)
- \$10,608 Annual Cost

During the Public Comment section of the April 19, 2018 Board meeting, Mr. Stephen Bigilen of Stephen Bigilen Video & Photography addressed the VRSD Board. Mr. Bigilen provided information about video recording services he provides for various public agencies, and he discussed some new legislation which he thought the VRSD
