APPROVAL OF A PROPOSED \$25,000 CHANGE ORDER TO INCREASE VRSD PURCHASE ORDER NO. 2734 WITH PORTER RENTS FOR HEAVY EQUIPMENT RENTAL SERVICES

RECOMMENDATION

Approve issuance of a change order to VRSD Purchase Order No. 2734 to Porter Rents to increase the amount by \$25,000 for a revised total compensation amount not to exceed \$50,000 for heavy equipment rental services.

FISCAL IMPACT

Funds required for this change order are included in the adopted FY2018-19 budget for Solid Waste operations (Account 25-401-52220-400300).

BACKGROUND/ANALYSIS

A purchase order was issued to Porter Rents on July 1, 2018, for heavy equipment rental services in the amount of \$25,000. Needs for these services at the Toland Road Landfill are difficult to predict and quantify on an annual basis, as key equipment can suddenly The additional amount of \$25,000 is needed to complete urgent earthwork and for any additional work that might come up before the end of FY2018-19.

The District keeps several open purchase orders with local and regional equipment rental service companies. Following the Thomas Fire, these companies are experiencing significantly low heavy equipment inventories due to the high demand for heavy equipment during the rebuilding process in Ventura County. As a result, staff has had to rely more heavily on Porter Rents, who has had the right pieces of heavy equipment available for the District's time-sensitive projects over the last few months.

This letter and the associated purchase order have been reviewed by VRSD legal counsel as to form.
