14. <u>General Manager Comments</u>

Chris Theisen, General Manager, updated the Board on the progress of meeting certain conditions in Toland Road Landfill Conditional Use Permit:

- <u>Condition 55b: Offsite Air Monitoring.</u> The data collection continues. The collection period is May 2023 to October 2023.
- <u>Condition 57: Dust Control Monitoring.</u> The data collection continues. The one-year collection period began in March 2023.

Richard Jones, Director of Operations, was asked to give an update on any impact to the Toland Road Landfill by the August 20th "Hurriquake" activity. Mr. Jones reported that all the VRSD monitored landfills were inspected for earthquake damage and none appear to have any problems. In preparation for the anticipated storm that brought 5.8 inches of rain and 35 m.p.h. winds, staff worked until 7:30 p.m. on the preceding Friday to lay out extra tarping, extra tires, etc., to secure the landfill. The Board expressed appreciation and asked that Solid Waste workers Miguel Arroyo, Saul Soto, and Jason Hoffman be recognized for their contributive efforts.
