APPROVAL OF CALIFORNIA OFFICE OF EMERGENCY SERVICES DESIGNATION OF APPLICANT'S AGENCY RESOLUTION FOR FEDERAL AND STATE FINANCIAL ASSISTANCE FOR DECLARED EMERGENCIES

RECOMMENDATION

Approve, and Direct the Ventura Regional Sanitation District (VRSD) Clerk of the Board to certify the California Office of Emergency Services (Cal OES) "Designation of Applicant's Agent Resolution for Non-State Agencies" (copy attached), which will renew VRSD's authorization for the VRSD General Manager, Director of Operations, and Director of Finance to act on behalf of VRSD in applying for federal and state government assistance in response to all open and future disasters for a period of up to three years.

FISCAL IMPACT

The Board's decision to renew authorization of the above resolution will have a material effect on VRSD's ability to secure federal and state financial assistance in connection with pending and future applications with the Federal Emergency Management Agency (FEMA) and Cal OES. Such financial assistance could range from several thousand dollars to hundreds of thousands of dollars, depending on the scope of individual federal or state-declared emergencies or disasters.

BACKGROUND/ANALYSIS

In the past three years, VRSD has applied for federal and state financial assistance in response to damages caused by the COVID-19 Pandemic, a government-declared disaster. Part of the application process includes submission of a resolution by the Clerk of the Board (with the Board's approval) that authorizes up to three (3) individuals to act on behalf of VRSD. Your Board last approved such a resolution in March of 2021, and the three-year effective period of that resolution will expire in a few days. An updated resolution is required in order for staff to complete pending applications and to be eligible to apply for future assistance as needed. Therefore, staff is recommending the Board's approval to renew the authorization for an additional three years.

In addition to naming the titles of individuals authorized to act on behalf of VRSD, the Designation of Applicant's Agent resolution for Non-State Agencies now requires the names of three members of the governing body who approved the document. Staff included the Chairperson (Director Newman), the Vice Chairperson (Director Villasenor) and the most recent past Chairperson (Director Kildee).
